

To maintain the children and youth we serve safely at home, in school, and in their communities by providing support, education, and advocacy; and connecting these young people to appropriate services and resources.






## Age Groups of Youth Served




## Average Youth Served per County

## Specialized Care Coordination

In addition to care management services, CGS is also part of the statewide collaborative response to address problematic sexual behaviors (PSB) between minors. Specialized Care Coordinators (SCCs) serve all counties in NJ and are based out of each Care Management Organization (CMO). Specialized Care Coordinators (SCC) help families and youth who were referred by NJ's State Central Registry (SCR) to access needed specialized health services (medical evaluations, evidence-based mental health services) at no cost to families. SCCs also engage in prevention and awareness efforts, providing presentations and trainings on PSB and NJ's PSB system. Both youth impacted by PSB, and youth who have engaged in PSB, may benefit from SCC services. These services support healing and help reduce the reoccurrences of PSB.

## DREAMS: Developing Resiliency through Engaging Approaches to Maximize Success

DREAMS is a collaboration between the NJ Department of Children and Families (DCF), Department of Education (DOE), and Children's System of Care (CSOC). DREAMS aims to support schools and communities to build stronger, more meaningful relationships and connection with students. DREAMS does this by bringing the Nurtured Heart Approach (NHA), Trauma-Informed and Healing Centered supports to assist educational staff and students to build positive relationships and emotional self-regulation.

Over four years, our team offered support to 25 schools across 11 districts in Cumberland, Gloucester, and Salem counties. In 2025, CMO partnered with the Family Support Organization (FSO) to provide mentor services to the following participating schools:

With funds made available by the Dept of Children & Families, our Care Management Organization (CMO) helped provide Community Resource Development (CRD) funds to local programs and services that support the well-being of youth and families in our communities. We were proud to have supported the following community resources in 2025:

### United Advocacy Group (UAG)

To expand the Kids Learning Academy after school program in Cumberland County. Also, to expand the Youth Mentoring Program in Cumberland, Gloucester, and Salem counties. The Youth Mentoring Program (YMP) was designed to serve youth at-risk for involvement in community-based violence and exposure to adverse childhood experiences (ACEs), by engaging them in group mentoring and healthy peer interactions.
